Correspondence read by Supervisor Brooks

- Supervisor Brooks thanks YMCA Director Jerry Huncosky for the \$8,500.00.monthly donation from the Frost Valley YMCA.
- The Town portion of Ulster County sales tax for the period between June and August is \$ 7,664.21.
- A letter informing the Town of a proposed merger between TWC and Charter.

Highway Report by Highway Superintendent Dan Van Sader

- New Road Hill / Denning Roads has been completed.
- Erts Brook culvert project is almost completed, needs blacktop and the railing installed.
- Motor paved sections of Red Hill Knolls Road, Round Pond and the hill of Porcupine Road.
- Black topped Van Aken and a section of Balace Road with the generous aid of the Town of Neversink. Highway Superintendent Van Saders thanks the Highway Superintendent and Town Board of the Town of Neversink for their aid.
- Supervisor Brooks also thanks both the Highway Superintendent and Town of Neversink for the Municipal Shared Service.
- Graded Brooks Hill, Whitehouse and Balace Roads and part of Sheeley Road.
- Highway Superintendent Van Saders opens a discussion on the 2008 truck, which is in the shop for repairs. Discussion follows.
- Councilman Gregory Vurckio remarks it should have been sent to Stadium first as they repaired the truck. He asks if the truck is being worked on or sitting and waiting?
- Highway Superintendent Van Saders will call Truck Pro and then depending on the answer, have truck towed to Stadium for repair.

- Highway Superintendent Van Saders is planning on chip sealing the newly paved roads on Thursday.

- Meeting with NYCDEP and NYSDEC this Thursday, regarding the Blue Hole and the water issue upstream.
- Discussion on the extra hours of work for the Court Clerk dealing with tickets. The Board authorizes the Supervisor to submit a voucher for the extra hours worked.
- ➤ Fourteen towns have signed on with the UCRRA, the Supervisor Association asked for a deadline extension as the hard deadline had passed. They agreed and because of that, additional towns signed on.
- Councilman Mike Dean thanks Supervisor Brooks for staying on top of the situation.
- Supervisor Brooks thanks the highway crew for all their moving expertise during the laying of new carpet in the town hall.
- ➤ Supervisor Brooks has spoken with Mr. Landon, who will complete the proposed zoning map at the YMCA with the aid of the new natural resource director. He informs Councilman Smith the zoning committee will have to meet 1 last time for a full review. The Town Board will then schedule a public hearing.

- > The zoning map will then be sent to Ulster County Planning Board for review.
- > Supervisor Brooks requests 2016 budget numbers from Highway Superintendent Van Saders.
- > Meeting the health insurance carrier on Friday for cost numbers.

- Spoke with Town of Olive Supervisor Sylvia Rozzelle, NYS Senator Seward was attending their Town Board meeting and she was willing to speak to him to help push thru rules and regulation changes for the Blue Hole. The Town will contact all of its elected officials for aid to push the new rules and regulations thru, as well as asking constitutes to contact too.
- Supervisor Brooks comments that he will amend minutes next meeting as he misspoke; the contract with UCRRA is for 5 years.
- > Councilman Paul Schoonmaker thanks Supervisor Brooks for his continuous efforts on the Blue Hole.
- Councilman Schoonmaker ask if there is any word on the post office yet?
- Response by Supervisor Brooks no, not yet, they move slowly.
