Dan Forger reported for the recruitment committee that he talked to Jeff Williams about recruiting members from Frost Valley.

Andy Ford reported that the capital planning committee will report under new business that the inventory update has been completed.

# Old Business:

Reimbursement for chief's vehicles policy: Andy Ford gave an overview of the reimbursement policy. Andy stated that outside council says it is perfectly fine to reimburse the fire police caption. Outside council said the best policy would be to determine the mileage from the fire house to the response site and back. Opened up for discussion at the next meeting Andy reported that the council took the most issue with is the chief getting reimbursed from work.

UPON MOTION by Dan Forger, Seconded by Terry McNamara is to leave the policy in effect with the addition of including the fire police captain. Andy Ford requested tabling the motion until the next meeting. Jim Tisch pointed out the policy was within IRS guidelines when looked at by the auditors. After discussion the motion went to vote. YES votes Terry McNamara, Dan Forger and Tony Carminati. NO votes – None. Abstained- Peter Donnolo and Andy Ford. Motion carried by a 3 to 0 vote.

Peter Donnolo questioned where the money will come from. Peter stated the approving the motion will put the account further over budget. It was stated this is a separate issue from the policy being modified.

Gary Frear stated that Chris McGrath is no longer going to be a chief because he relocated further out of the district.

Peter Donnolo brought up the question of how the taxes are calculated. Andy Ford reported that he still needed to research it.

# New Business:

Jim Tisch reported that the inventory project was completed by the consultant. It will be discussed at the next committee.
